#### FINANCIAL REPORT

- 1. Review of Financial Charts. Note that the carryforward is \$30K higher due to grant for summer wildland coverage deposited in 23/24 fiscal year.

#### CHIEF REPORT

- Revenue updates:
  - o Expecting about \$10K for the initial conflagration deployment. They were redeployed to Burns and we could potentially receive an additional \$10K.
  - o The construction site for the new Rec Ctr, needed water spread and Rollie ran the tender for 12 days (at \$1,200/day).
- Congresswoman Val Hoyle visited on July 4<sup>th</sup> for about 45 minutes. Sounds like the grant to build the expanded station will be approved. Senator Merkley indicated that he can help for the remainder needed.
- Plan on doing a review in September to the Strategic Plan that was created 10 years ago.
- Potential Volunteer motto, "Pride, Passion, and Professionalism"
- Grants:
  - o OEM Grant should have a decision by 7/31/24. If this doesn't come through we may get a line of credit from US Bank for the funds needed on the rescue.
  - 1. Question by Patti on the sale of the trailer no interest thus far.
  - 2. Question by Gerry on the call data. This is still a work in process. The call information is correct but the timing is off.
